



Contract of Service

Services: Face painting, Balloon twisting, Glitter tattoo, Glitter bar, Henna, Waterproof face painting.

- **Birthday Parties**

(All guest will be painted with full face, cheek or arm designs of their choice and/or receive a twisted balloon of their choice)

An average of 9-12 guests will be served per hour.

- **Group Events (including Festivals, Corporate Events, Etc.)**

(Each person will be given the option of smaller designs displayed on a board)

An average of 15 guests will be served per hour.

- **Halloween make up**

(Any design of client choice)

An average of one client will be painted per hour depending on complexity of design.

- **Balloon party delivery**

(Balloons will be delivered the day of the party)

Hand painted balloon +twisted balloon+candy cup for birthday boy/girl and twisted balloons for all guests

Face Painting: \$150 per hour.

Balloon twisting:\$160 per hour

Glitter tattoo: \$150 per hour.

Glitter bar: \$140 per hour

Waterproof Face Painting: \$160 per hour.

Henna: \$150 per hour.

Belly paint and Halloween makeup: Price varies depending on complexity of the chosen design.

Balloon party delivery: Price varies 99_150 depending on complexity of designs and amount of guests balloons.

- **2 services 1 artist**

to add balloon twisting _\$50 extra

to add glitter tattoo _\$50

to add henna_\$50

to bring pre twisted balloons_\$50(up to 15)

Please be considerate of the time you book request. If you're not sure how long to book us- we are happy to advise you.

Travel Expense: A travel fee will be added to events located 20 miles or more from the local area. The fee amount is determined by the distance to the event location.

Terms of payment to Agent: A 50% non-refundable retaining fee is required 24 hours of date of contract to secure the booking date. The remaining balance should be paid one day before the event. I will bring my own supplies, table and chair, just provide a space.

Client should pick one of the following options:

- Client request that, if the painter's schedule allows, painter can complete all guests desiring painting and agrees to pay an additional fee in half-hour increments, until all guests are served, or the painter is no longer able to stay. \$50 per half-hour increments.
- Client requests that painter promptly closes the line and cuts off services at the original ending time agreed upon. Client understands that this may not accommodate all guests desiring to be painted.

Additional Information: All events booked rain or shine event. Artist is to arrive 15 minutes prior to start time to set up. Artist requires a well-lit area approximately 6ftx6ft in order to set up. For sanitary reasons artists may not paint a person who is exhibiting signs of illness nor may the artist paint a person who has a wound or open skin. Skin must be clean of dirt and food in order to be serviced. The artist's supplies may not be handled by guests of the event. If a guest misuses the artist's supplies, the client may be asked to replace the supplies. Artist use only FDA approved paints, as with any products, a small portion of people may develop a sensitivity to an ingredient in the supplies. Persons who believe they may have a sensitivity to any of the products may request a patch test 30 minutes prior to receiving services. Artist will use reasonable care but is not responsible for damage to clothing or property. If the event is to be held outdoors, tent/ canopy must be provided by purchaser to protect artists from sun/rain/extreme heat or cold, etc.

Customer Cancellations must be no less than 14 days prior to date of party in order to receive refund of payment less retaining fee. Retaining fee is non-refundable, but is transferable if you reschedule at a later date, up to a year. Please check with the artist's schedule to ensure you obtain the date you desire for entertainment. Also, please be advised that weather may affect your outdoor events. Having an alternate plan would be highly recommended. Cancellations within 48 hours of event require event fee to be paid in full.

Agent Cancellations: If retaining fee is not received within 24 hours from date of contract, artist has the right to cancel reservation and fill spot with another client. Artist has the right to cease painting and leave without refunding any monies if there are extreme adverse weather conditions that make it unsafe for the artist to paint.
